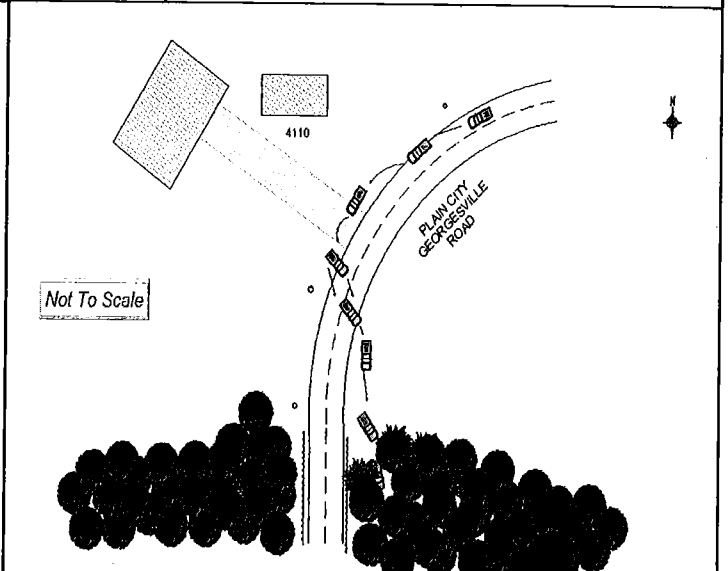

NARRATIVE

UNIT 1 WAS SOUTH BOUND AT 4110 PLAIN CITY GEORGESVILLE ROAD. UNIT 1 LEFT THE RIGHT SIDE OF THE ROADWAY, OVER CORRECTED AND LOST CONTROL TRAVELING BACK ACROSS THE ROADWAY TRAVELING OFF THE LEFT SIDE OF THE ROAD. IT CONTINUED THROUGH THE FIELD AND DOWN A HILL INTO THE WOODS. THE VEHICLE SUSTAINED HEAVY DAMAGE. THE OPERATOR APPEARED TO BE VERY INTOXICATED AND ADMITTED TO DRINKING. HE WAS UNABLE TO PERFORM THE STANDARDIZED FIELD SOBRIETY TESTS BECAUSE HE WAS TO INTOXICATED. HE REFUSED BREATH AND URINE TESTS.
