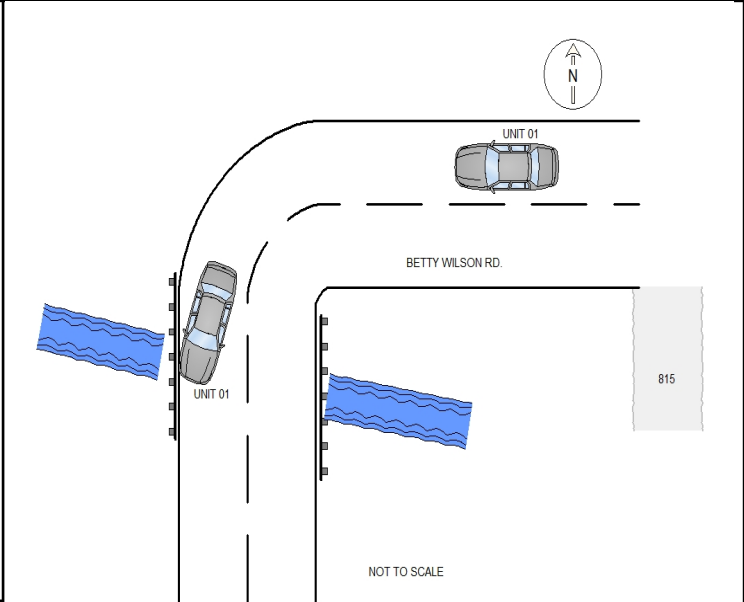

NARRATIVE  
UNIT 01 WAS TRAVELING WEST BOUND ON BETTY WILSON RD AT A 90 DEGREE CURVE. UNIT 01 SLID THROUGH THE CURVE STRIKING THE GUARD RAIL ON THE WEST SIDE OF THE ROADWAY. THE STRIKE FROM UNIT 01 CAUSED THE GUARD RAIL TO COME SEPARATED FROM THE BRIDGE. UNIT 01 THEN ATTEMPTED TO FLEE THE SCENE, BUT STOPPED IN A NEARBY DRIVEWAY WHERE BARKER'S TOWING RECOVERED IT. THE DRIVER OF UNIT 01 DID NOT REPORT THIS TO ANY LAW ENFORCEMENT AGENCY AT THE TIME OF THE COLLISION.
