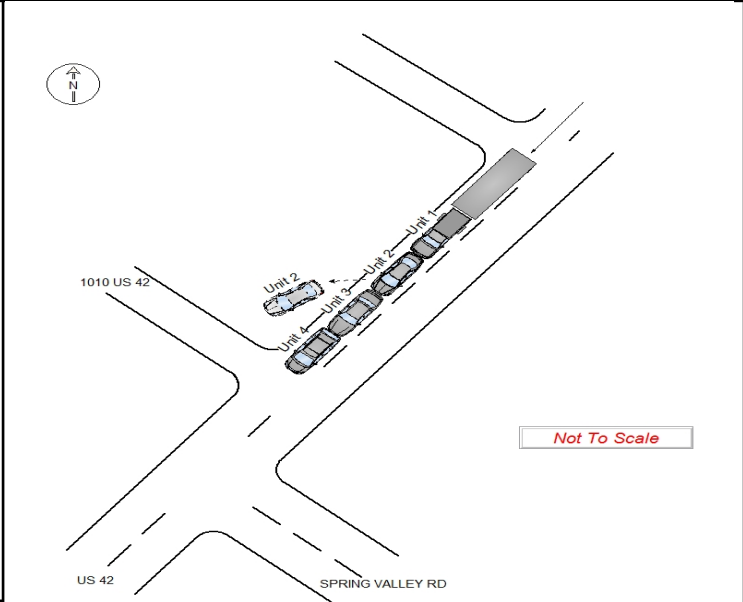

UNIT 01 STRUCK UNIT 02 IN THE REAR CAUSING IT TO STRIKE UNIT 03. UNIT 03 WAS CAUSED TO STRIKE UNIT 04 DUE TO BEING STRUCK IN THE REAR. UNIT 01 WAS PULLING A CAR HAULER STYLE TRAILER (OHIO REGISTRATION TQQ9146) WITH A FORD INSIDE. THE VEHICLE IN THE TRAILER BROKE FREE FROM ITS TIE DOWNS AND CAUSED DAMAGE TO THE VEHICLE AND THE INTERIOR OF THE TRAILER.
