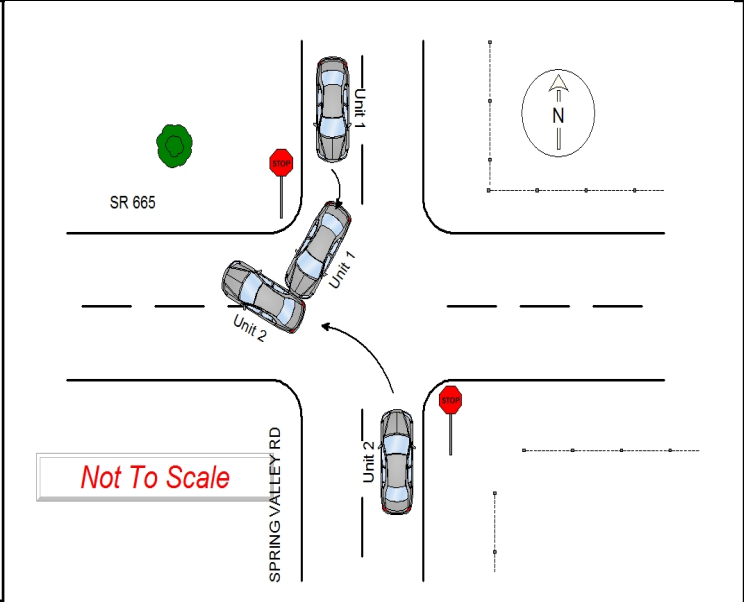

NARRATIVE

UNIT 1 WAS FACING SOUTH ON SPRING VALLEY RD AT SR 665 AND UNIT 2 WAS FACING NORTH ON SPRING VALLEY AT SR 665 BOTH STOPPED AT THE STOP SIGN. UNIT 2 HAD THE RIGHT AWAY AND THE DRIVER OF UNIT 1 STATED HE KEPT WAVING UNIT 2 TO GO. THEY BOTH PROCEEDED TO MAKE THEIR TURNS TO GO WEST BOUND ALMOST AT THE SAME TIME. UNIT 1 STRUCK UNIT 2 IN THE REAR PASSENGER SIDE WHEEL CAUSING DAMAGE.
