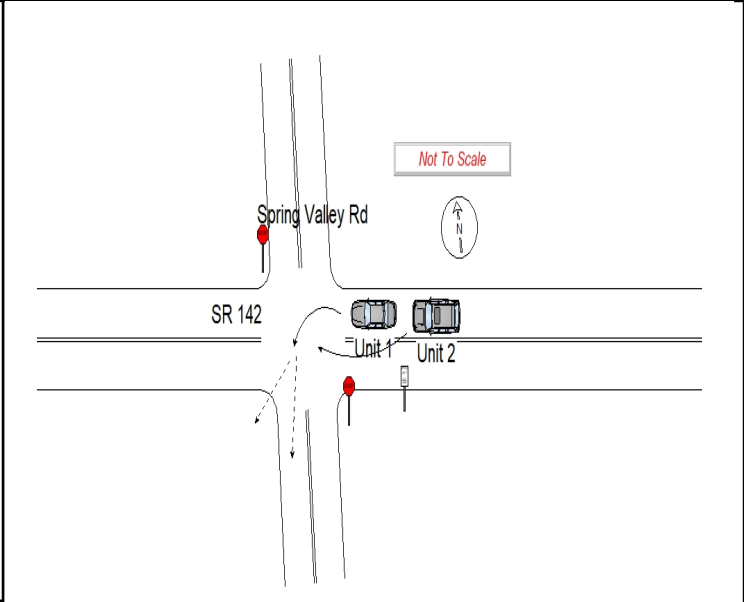

NARRATIVE

Unit #1 and #2 were west bound on SR 142 into City of London. Unit #1 initially indicated a right turn but, as she approached the intersection abruptly changed signal indicator and turn decision to make a left hand turn onto Spring Valley Rd. However, Unit #2 had already started to pass Unit #1 on the left hand side as they came into the intersection anticipating a right hand turn leading to a collision in the intersection.


