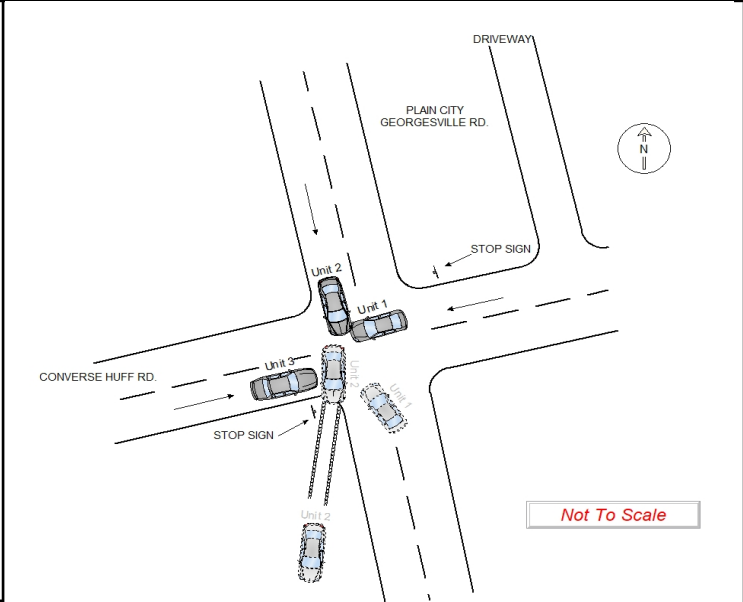

UNIT 02 TRAVELING SOUTH BOUND PLAIN CITY GEORGESVILLE RD. WHEN UNIT 01 PULLED INTO HIS LANE OF TRAVEL FROM THE STOP SIGN. UNIT 01 WAS TRAVELING WEST BOUND CONVERSE HUFF RD. AND FAILED TO YIELD TO UNIT 02 CAUSING HIM TO STRIKE HER PUTTING UNIT 01 INTO A SPIN AND COMING TO FINAL REST IN THE INTERSECTION FACING THE OPPOSITE DIRECTION OF TRAFFIC. UNIT 03 WAS SITTING AT THE STOP SIGN FACING EAST BOUND ON CONVERSE HUFF RD. AND WAS STRUCK BY UNIT 02 AFTER THE COLLISION WITH UNIT 01.
