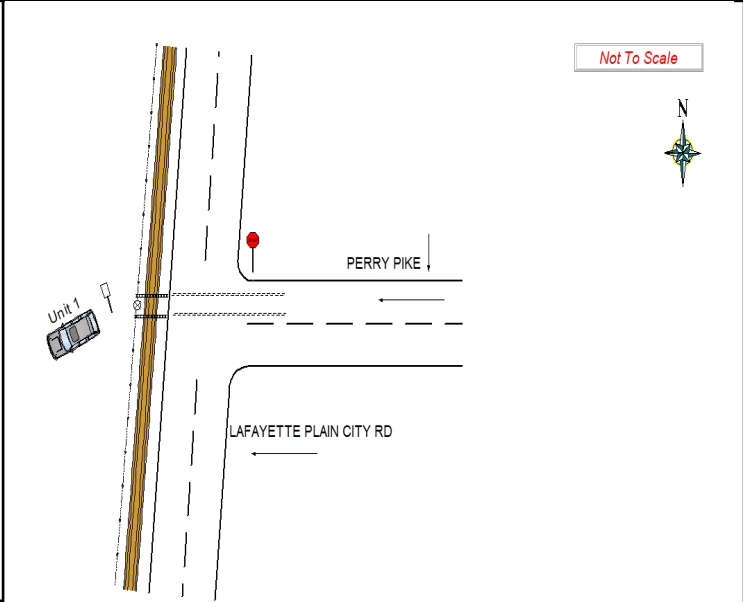

THE COUNTY ENGINEERS OFFICE WAS ADVISED OF THE ROAD SIGN THAT DESIGNATED THE NAMES OF THE ROAD WAS STRUCK AND REMOVED FROM THE GROUND.
