IT THEN CONTINUED ACROSS THE INTERSECTION AND IN TO THE FRONT YARD OF 550 US 42 SE TRAVELING BETWEEN SOME TREES BEFORE STRIKING A CHAIN LINK FENCE. THE DRIVER AND PASSENGER COMPLAINED OF MINOR INJURIES BUT DID NOT WANT TO SEEK MEDICAL TREATMENT. THE DRIVER OF UNIT 1 WAS CITED FOR A SEATBELT VIOLATION AND RELEASED.
