<b>NARRATIVE</b> Unit 1 was traveling northbound on Spring Valley Rd. Unit 1 made a complete stop at the stop sign at the State Route 665 and Spring Valley Rd intersection. Unit 1 thought the roadway was clear to continue northbound on Spring Valley Rd., but was unable to see around the overgrown vegetation and did not see Unit 2's dimly lit headlights. While Unit 1 was traveling northbound through the intersection, Unit 2 was traveling eastbound on State Route 665. Unit 2 struck the driver's side of unit 1.

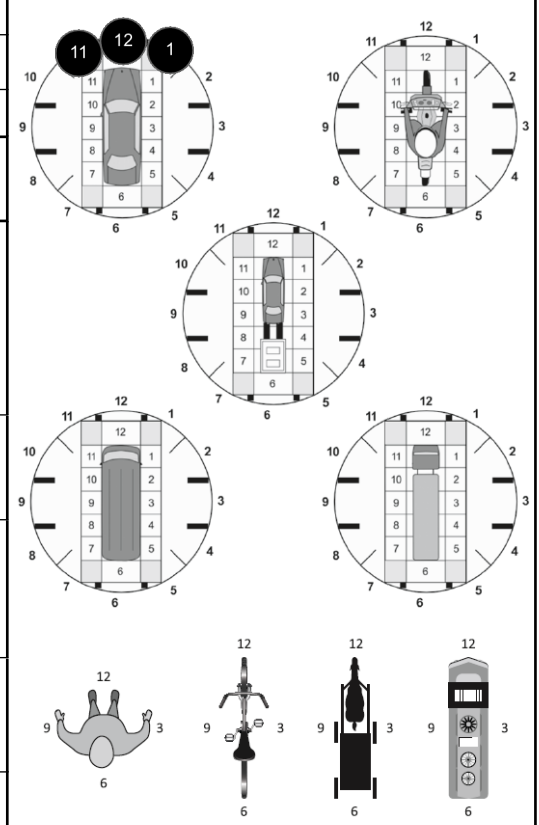
