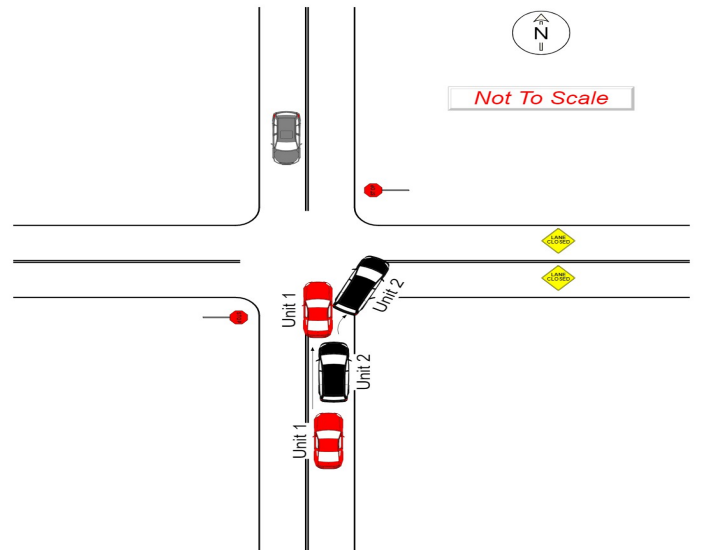

Unit 2 slowed down to make a right turn, eastbound onto Lucas Rd. The operator of Unit 2 realized eastbound Lucas Rd was closed, and slowed to almost a stop, mid-turn. A vehicle was traveling southbound in the southbound lane, so Unit 1 attempted to swerve to the left to pass Unit 2, but could not enter the other lane. Unit 1 struck Unit 2 in the tail light and continued to side swipe Unit 2.

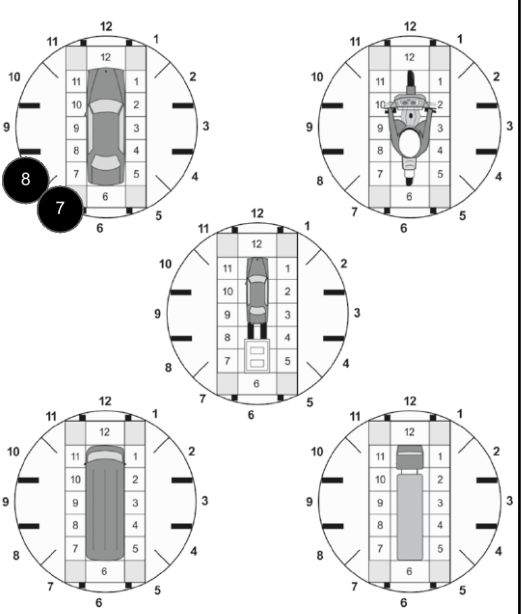

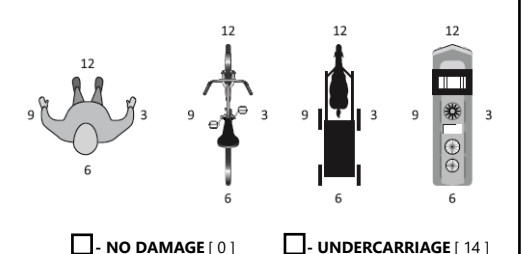
