Unit 1 was traveling southbound on Lafayette-Plain City Rd, stopped at the stop sign at State Route 29. Unit 2 was traveling eastbound on State Route 29. Unit 1 failed to yield at the stop sign and pulled out in front of Unit 2 and was struck by Unit 2. Both vehicles then left the roadway on the southeast corner of the roadway. Unit 2 struck a utility pole and Unit 1 struck a cornfield.

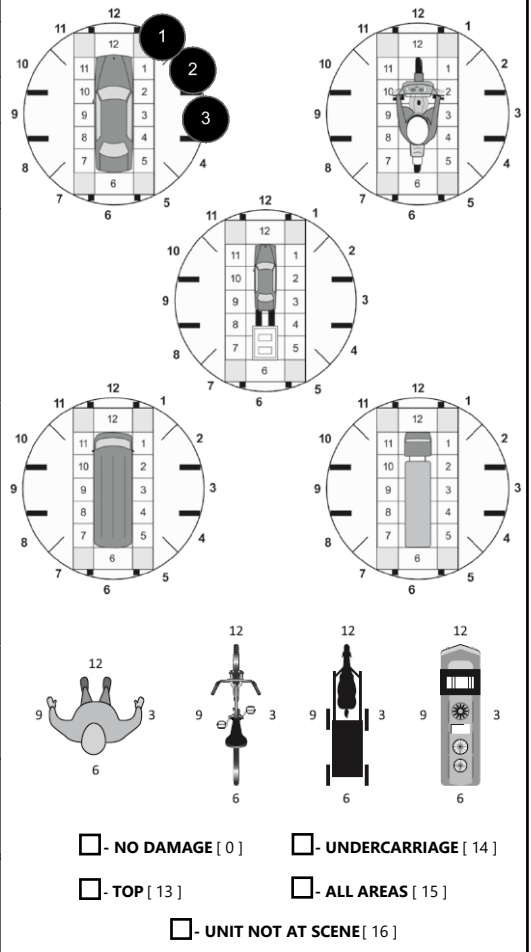

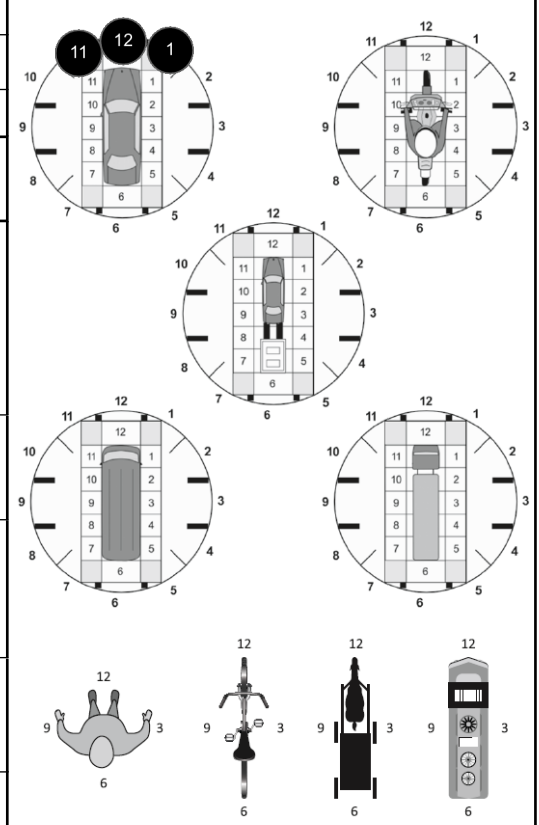
