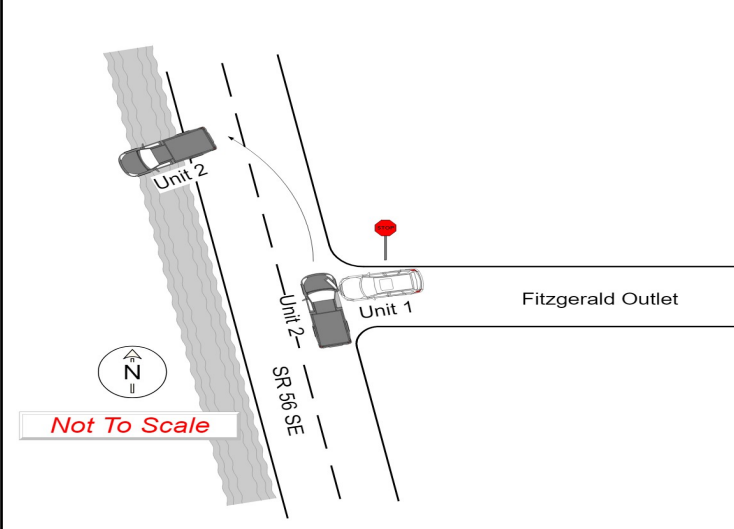

NARRATIVE Unit #1 was stopped at the stop sign on Fitzgerald Outlet. Unit #2 was NB on SR 56. Unit #1 did not see Unit #2, pulled onto SR 56 and struck the passenger side of Unit #2 as it was passing Fitzgerald Outlet. The rear axle and tire of Unit #2 were detached from the impact, causing Unit #2 to cross the center line and opposite lane of travel before striking the ditch and coming to a rest.

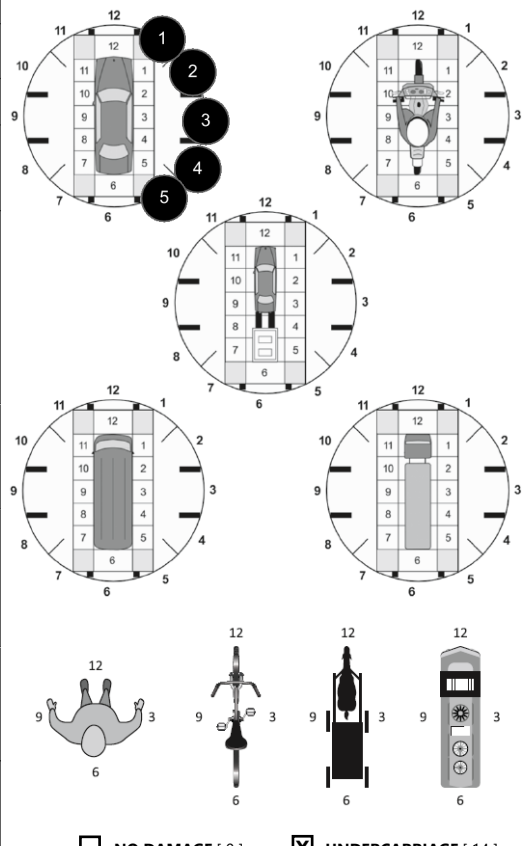
