NARRATIVE Unit 01 was westbound on Cemetery Pike at Plain City Georgesville Road. Unit 01 failed to observe Unit 02 which was southbound on Plain City Georgesville Road, and pulled into Unit 02's path. Unit 02 swerved to attempt to miss Unit 01. However, Unit 02 still struck the right front fender of Unit 01 with its left front. Unit 02 then separated from the initial crash and continued onto Converse Huff Road where Unit 02 stuck a stopped Unit 03. Unit 02's vehicle received disabling damage as a result of the crash. Unit 02's vehicle was later towed from the scene by Brigg's Towing and Recovery. Both Unit 01 and Unit 03 received damage, they were later driven from the scene. Unit 02's driver complained of possible leg injury. Unit 03's driver complained of lower back pain. Unit 01 was issued a citation for failure to yield from a Stop Sign.
