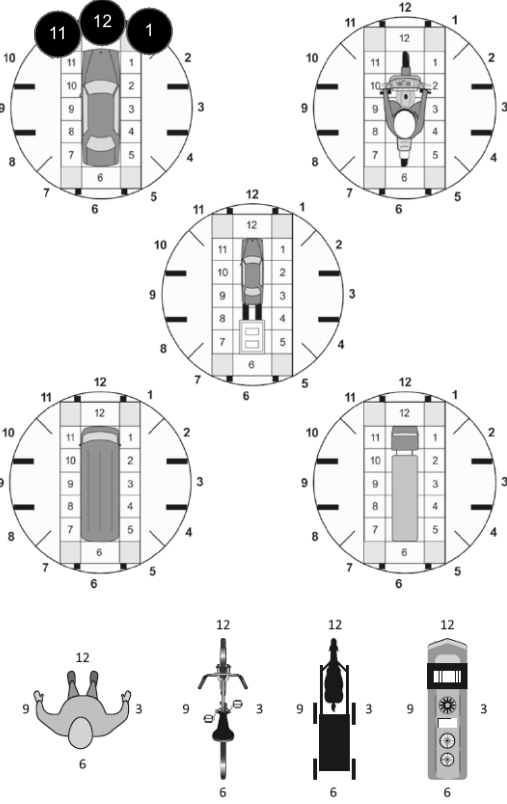

NARRATIVE On the listed date and time, I was dispatched to the intersection of Plain City Georgesville Rd and Converse Huff for a non-injury crash. Upon my arrival both vehicles were parked in the grass facing northbound on Plain City Georgesville Rd. Unit #1 a silver Kia K4 (Bearing OH Reg. KTE4528) was driven by Danny Bentely who was at the stop sign on Converse Huff traveling eastbound. Unit #2 a gray Honda Civic (Bearing OH Reg. V457573) was driven by Riley Magginis, with a passenger, Rebecca Magginis. Unit #2 was traveling northbound on Plain City Georgesville Rd. Unit #1 failed to stop and struck Unit #2 in the driver's side door when proceeding eastbound. Both vehicles sustained disabling damage, both vehicles were towed from the scene by Kirby's Towing. Riley was later seen at a medical facility to be treated for suspected minor injuries. Danny was subsequently issued a citation for 4511.43A Stop Sign and 2152.02N Juvenile Traffic Offender.
