Unit 1 was unable to negotiate the curve, leaving the left side of the roadway and eventually striking an embankment for a driveway. Unit 1 the went airborne striking a speed limit sign before returning to the ground. Unit 1 then struck another embankment for a field access causing it to roll over and hit a curve warning sign. Unit 1 came to a rest on all 4 wheels, and both signs that were struck were removed from their fixed positions, needing replacement.

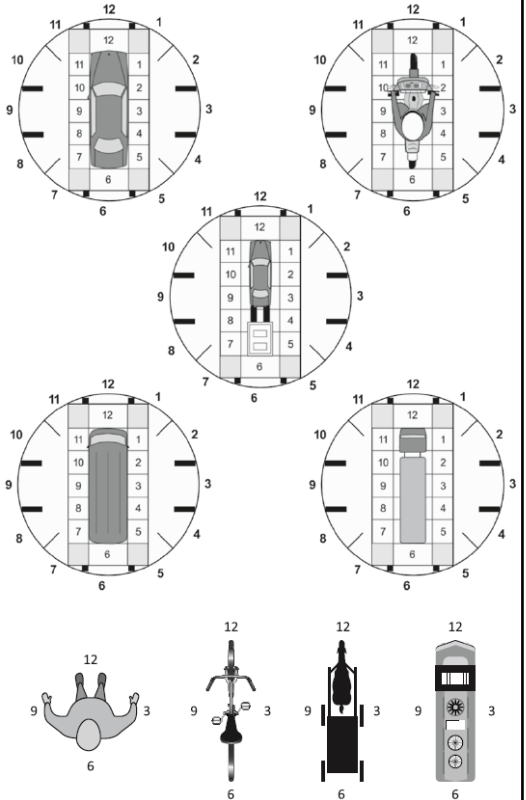
