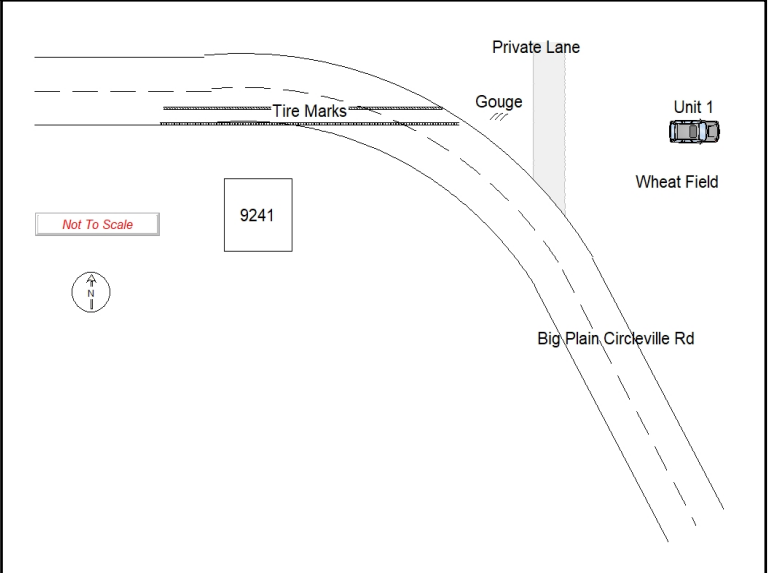

NARRATIVE
 Unit #1 was EB on Big Plain Circleville Rd. Unit #1 failed to navigate the curve exited the road after appx 60 feet of tire marks on road pavement, was airborne as all tires left the surface of the ground in the grade of the ditch, landed leaving gouge marks in the field and continued appx 125 feet into final rest in a wheat field east of 9241 Big Plain Circleville Rd. Inside the vehicle was found in the box power steering pump and power steering replacement line which the driver believes had a contributory effect in the crash.
