NARRATIVE

Unit 1 was traveling south on U.S. Route 42. Unit 2 was stopped facing southbound on U.S. Route 42 waiting to make a left turn. Unit 1 failed to maintain assured clear distance ahead and drove off the right side of the roadway into a parking lot to avoid striking Unit 2. Unit 2 made a right turn into the parking to avoid being rear ended by Unit 1 and was struck by Unit 1. Unit 1 then struck Unit 3 and Unit 4 who were parked in the parking lot.

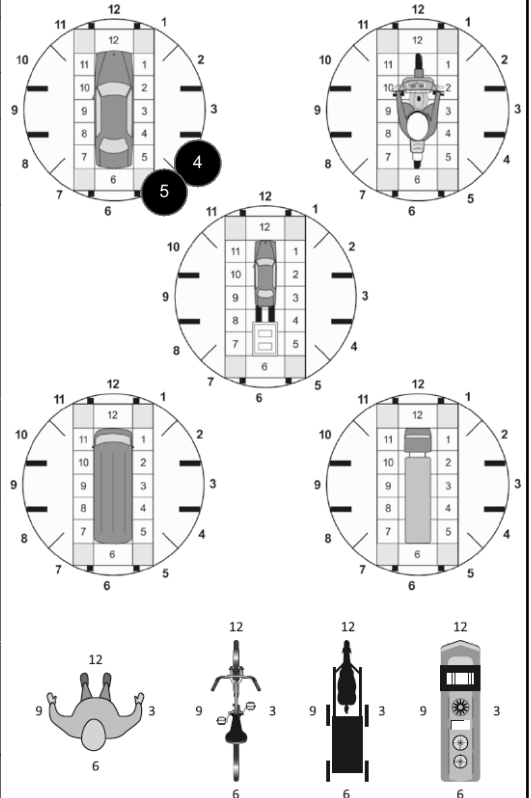
