NARRATIVE
Unit 1 was northwest bound on Middle Pike when it failed to negotiate a curve, crossed the centerline, went off the roadway to the left, came back on the road, spun and crossed the centerline a second time, went off the roadway to the right, struck a utility pole, and came to final rest in the yard of 2531 Middle Pike.
