At a Meeting of the Commissioners Ordered that the Report of the following Road be recorded and opened according to law (By) Agreeably to an order of the Board the Comd of Madison County Made at their last Meeting I proceeded on the 18th inst under the direction of Mr Johnston Mr Hall, and George McClimans Viewers, to Survey a Road as prayed for Beginning at the County line between Madison and Fayette Counties near John Saltmours where the Bloomingburgh Road Strikes said line running N 30 W 260 poles N 39 W 640 poles to corner of G Hollands Orchard thence N 16 W 320 poles N 44 W 120 poles N 18 W 80 poles N 44 W 160 poles passing through Mr Bindens lane, thence N 10 W 94 poles N 11 E 150 poles N 26 W 124 poles North 194 poles N 20 W 355 poles N 32 W 86 poles N 17 W 90 poles N 86 W 38 poles N 17 W 102 poles intersecting Sanghams Road about thirty poles Northwest from Reuben Broggs house Making the distance of said Road Nine Miles 57 poles

Whereupon it was ordered that Daniel Reid James Gury and Joseph Mitchell Viewers and David Chapman Surveyor Meet at George Shullingtons on the last Saturday in this inst and proceed to view and report thereon to the next Meeting of this board. County to pay no cost except the Surveyor

In Compliance with your Order to me directed I proceeded on the 26th instant to Survey the alteration of a Road beginning at the bridge across Barren Run near George Shullingtons to intersect the Downing Road near the big blade. Beginning at Barren Run bridge thence S 32 W 52 poles thence S 39 W 157 poles S 47 W 88 poles thence S 56 W 59 poles 1st Mile at 26 poles thence S 75 W 36 poles S 68 W 120 poles thence S 58 W 106 poles to intersect the Downing Road near the big blade bridge
