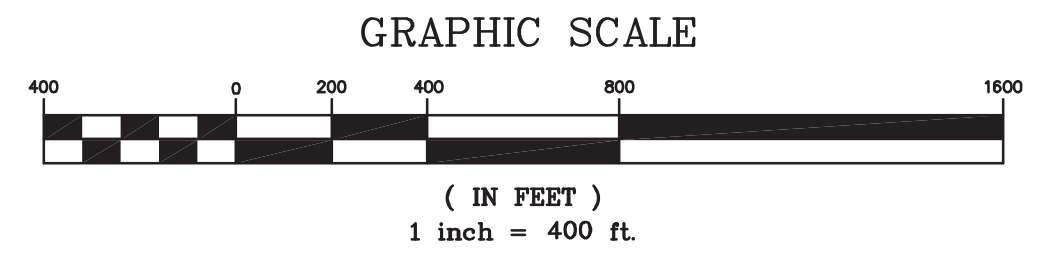
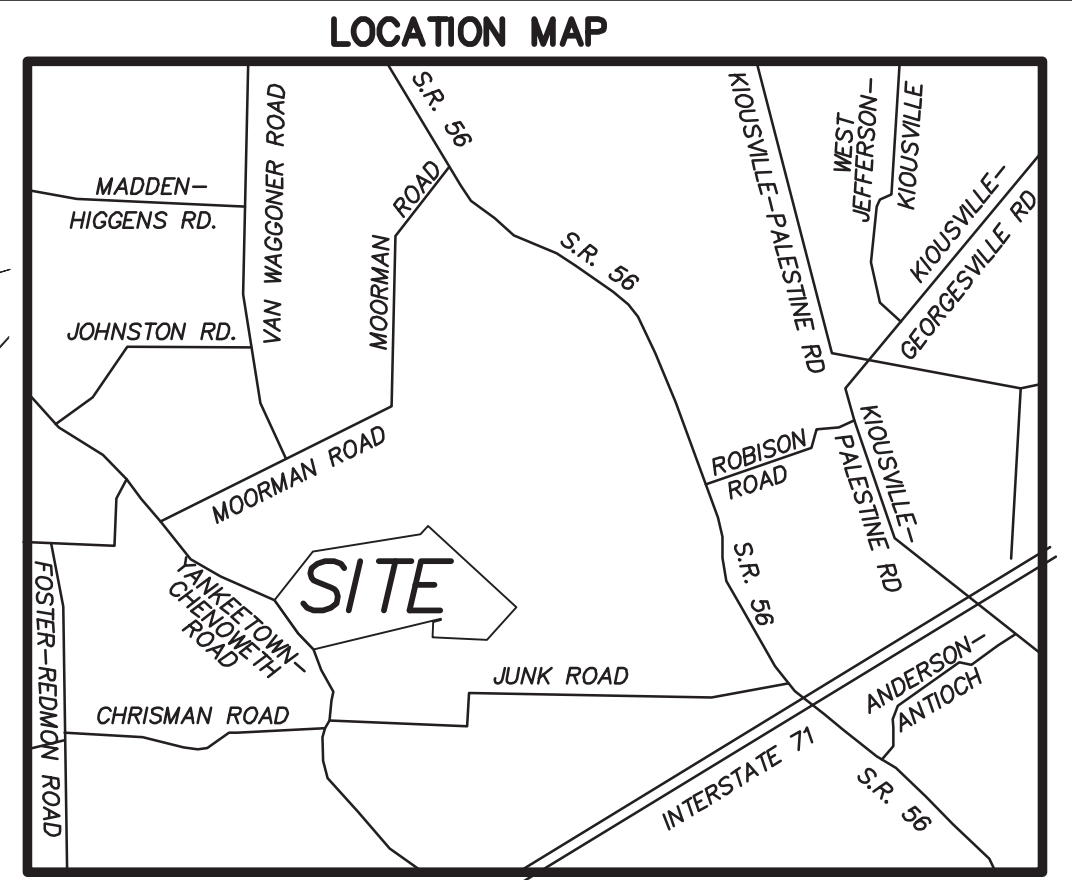


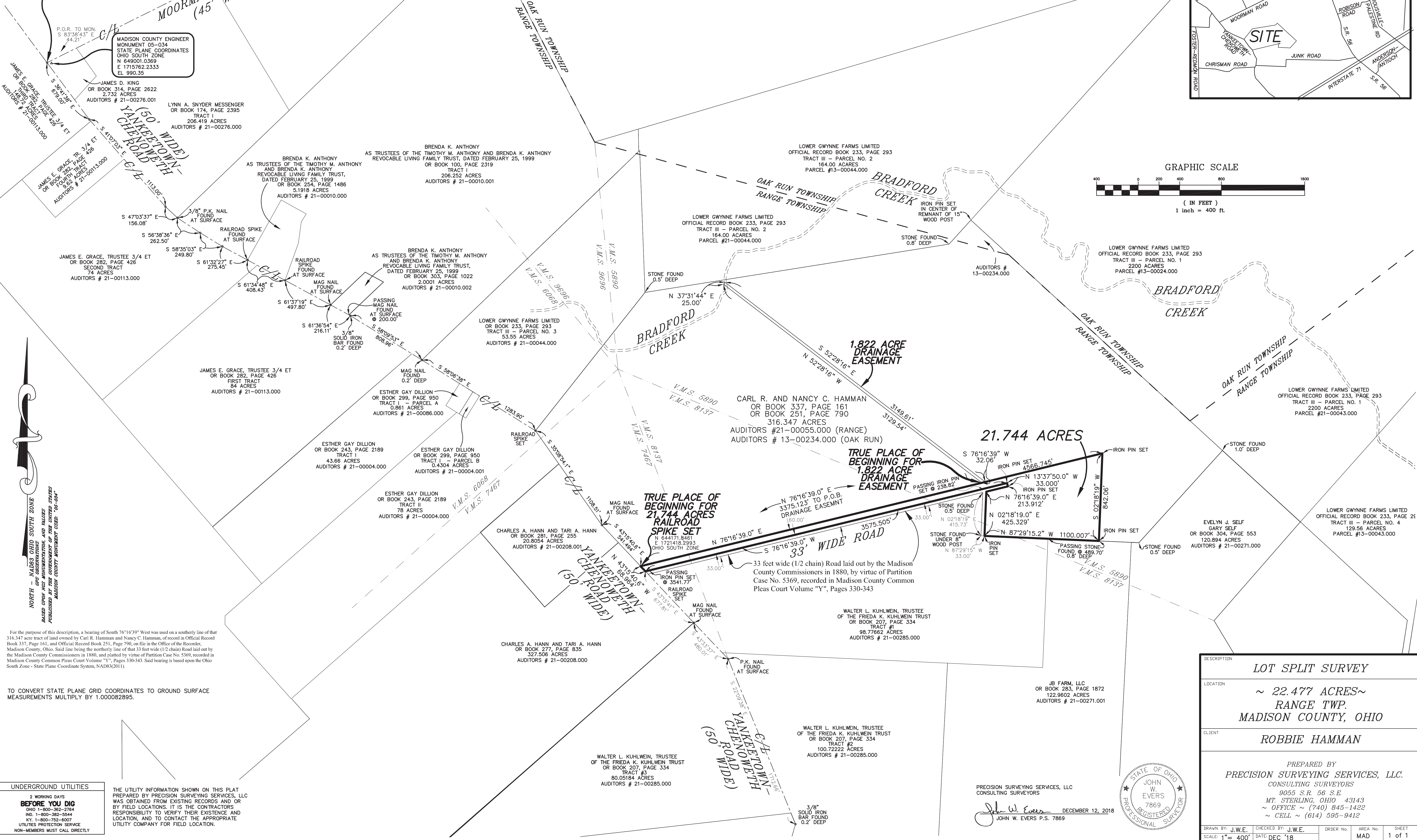

Said bearing is based upon the Ohio South Zone - State Plane Coordinate System, NAD83(2011).

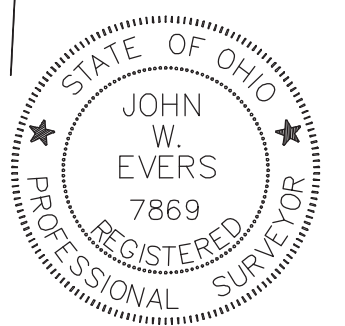

Kuhlwein, Trustee of the Frieda K. Kuhlwein Trust, of record in Official Record Book 207, Page 334, passing from Virginia Military Survey No. 5890, and into Virginia Military Survey No. 8137, a distance of **1100.007** feet to an iron pin set at a southwesterly corner of said 316.347 acre tract, being at the easterly edge of the southerly terminus of a 33 feet wide (1/2 chain) Road laid out by the Madison County Commissioners in 1880, by virtue of Partition Case No. 5369, recorded in Madison County Common Pleas Court Volume "Y", Pages 330-343, passing a stone found at a northwesterly corner of said 122.9602 acre tract, being a northeasterly corner of said 98.77662 acre Tract #1, at a distance of 489.70;(*for further reference said iron pin set is witnessed by a stone found which lies beneath an 8 inch diameter wood fence post which bears North 87°29'15.2" West, along the southerly terminus of said 33 foot wide Road, being the northerly line of said 98.77662 acre Tract #1, at a distance of 33.00 feet, marking the westerly line of the southerly terminus of said 33 foot wide Road, and being a corner of said 98.77662 acre Tract #1, Thence North 02°18'19" East, along the westerly line of said 33 foot wide Road, being an easterly line of said 98.77662 acre Tract #1, a distance of 415.73 feet to a stone found)*




