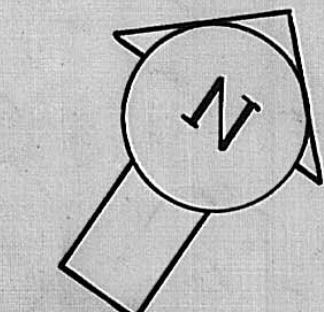
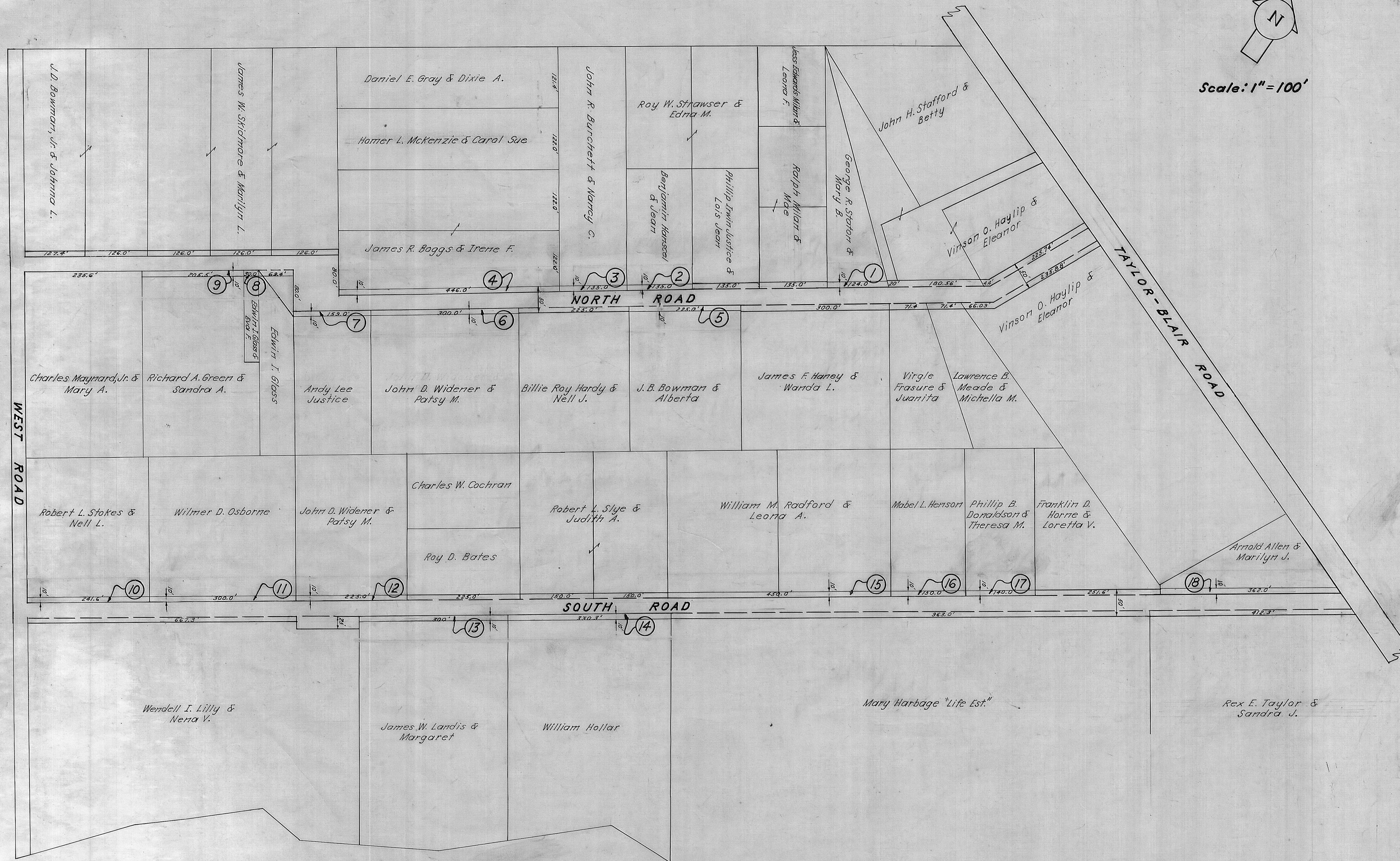


SIEBOLD ADDITION JEFFERSON TWP. - MADISON CO. OHIO
