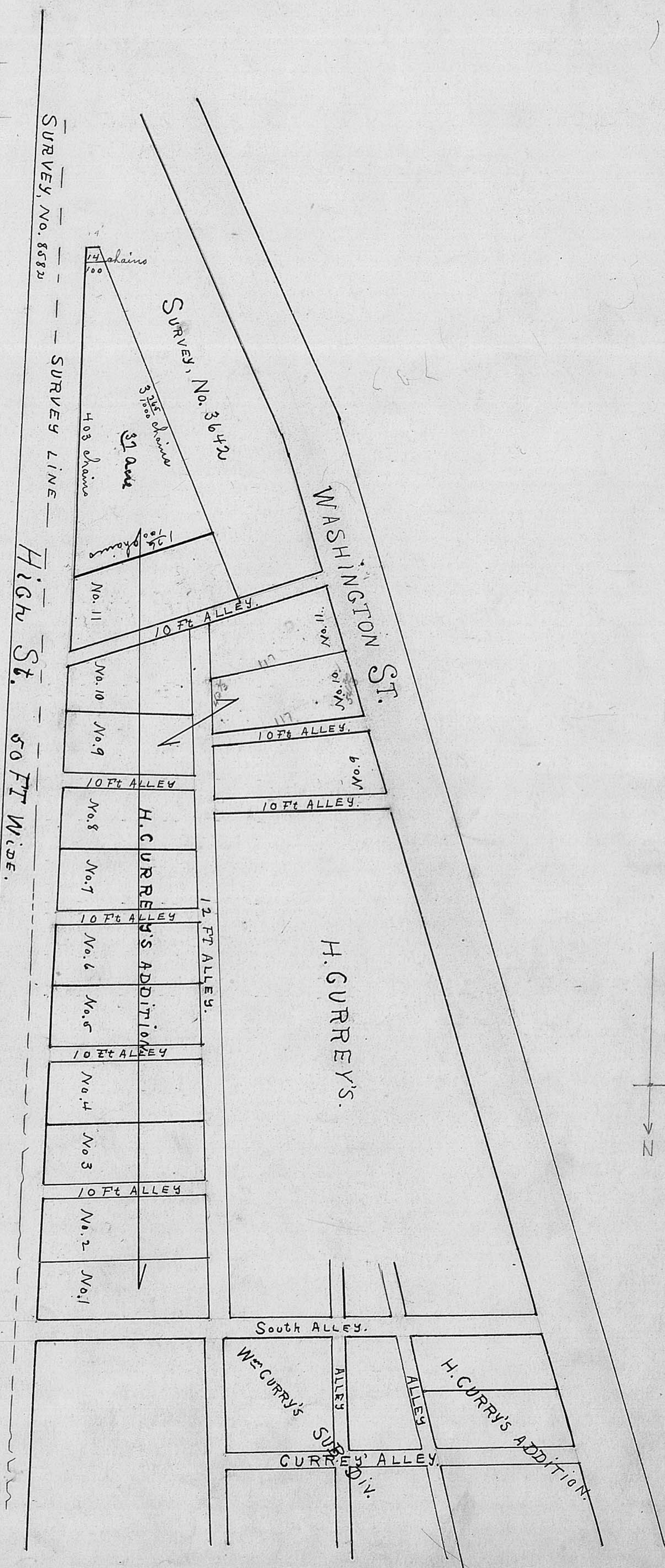

South Solon, Ohio. N. Curry's Addition

At the instance of N. Curry, I have surveyed a part of the following described tract of land, to-wit: Beginning at a stake in the south line of an Alley and in the east line of Survey #3642, and being a corner to Stenevia Smith; Thence with said Survey S. 3° 30' W. 913 1/2 feet to a stake northeast corner to Clementine Fandre; Thence with her north line S. 79° W. 14 feet to a stake southeast corner to M. Kingfield; Thence with the east line of said Kingfield and Catharine Morris N. 20° 45' W. 369 feet to a stake in the south line of Cynthia Harper; Thence with three lines of said Harper N. 71° E. 69 feet to a stake; Thence N. 14° 45' W. 50 feet to a stake; Thence S. 71° W. 153 feet to an iron pin in the center of Washington Street; Thence with the center of said Street N. 15° 15' W. 130 feet to an iron pin; Thence with the south line of a 12 foot alley N. 89° E. 137 1/2 feet to a stake; Thence N. 15° W. 62 feet to a stake in the south line of Charlotte Curry; Thence with three lines of said Curry east 15 3/8 feet to a stake; Thence N. 14° W. 50 feet to a stake; Thence W. 16.7 feet to a stake; Thence with the east line of a 12 foot alley for two calls N. 15° W. 108 1/2 feet to a stake; Thence N. 1° W. 209 1/2 feet to a stake in the south line of an Alley; Thence with said line S. 89° 30' E. 246 feet to the beginning, containing 3.56 Acres of land, being part of Military Survey #3642. There being 3.40 acres in the corporation of South Solon and 0.16 acres in Stokes Township, Madison County, Ohio

I have also divided a part of the same into Lots, Streets and Alleys as shown by and on the accompanying plat. All alleys are 10 feet wide, except alley at rear of Lots is 12 feet wide. The following table shows the dimension of the lots, the letters N. E. S & W. denote North, East, South and West respectively.



D. 1908; by an Ordinance, passed by yeas and nays vote, the plat of lots and streets and alleys of N.
